

We are delighted that you have chosen Allum at S Post Oak Apartments as your new home! To help in making your decision, we have listed the criteria for qualifying as a resident with us.

- A separate rental application must be fully completed, dated and signed by each applicant and all coapplicants 18 and over
- The rental application will be reviewed when submitted so we'll have all information needed to determine your eligibility.
- Each applicant must provide government issued photo identification.
- Applicants who are 1st time renters or who do not have enough income under paragraph 6 below may qualify by having the lease guaranteed by a guarantor. The guarantor must have a gross monthly income of at least 5 times the rent and must meet all other qualifying criteria. The guarantor must complete and sign a lease guaranty agreement. Guarantors may be held responsible for all the lease obligations, including the entire rent and other costs such as damages, even with roommates.
- Maximum number of occupants:
 - Two bedroom Five (5) persons
- Employment and monthly income must be verifiable. Total monthly income of all applicants must be 3 times the rent. (Otherwise, guarantor is necessary.)

Income will be verified by one or more of the following:

- Three (3) most recent paycheck stubs
- Three (3) most recent bank statements
- Applicant(s) may be denied occupancy or assessed a RISK FEE (Up to one month's rent/ Non Refundable) for the following reasons:
 - Falsification of Information on application
 - Incomplete application by any applicant
 - Insufficient income (total of all applicants)
 - Criminal convictions.
 - Poor rental profile of any applicant (rental history reports are obtained)
 - ❖ Non payment of rent or frequent late payments
 - Evictions
 - Drug use
 - Poor Housekeeping
 - Unruly or destructive behavior by applicant or applicant's guests
 - Violence to persons or property by applicant or applicant's guests
